Members of the press and public may tweet, blog etc. during the live broadcast, as they would be able to during a regular Committee meeting in the Council Offices. It is important, however, that Councillors can discuss and take decisions without disruption, so the only participants in this virtual meeting will be the Councillors concerned and the officers advising the Committee.

Disclosing Pecuniary Interests - What Must You Do?

(a) You must complete a declaration of your disclosable pecuniary interests, including those of your spouse/civil partner (or someone with whom you are living as such) and send it to the Monitoring Officer within 28 days of your election or appointment to the Council.

(b) When you attend a meeting of the Council, Cabinet, Scrutiny Board, Committee, Sub-Committee or Joint Committee etc, and a matter arises in which you have a disclosable pecuniary interest, unless you have been granted a dispensation, **you must:**

- Declare the interest if you have not already registered it
- Not participate in any discussion or vote
- Leave the meeting room until the matter has been dealt with
- Give written notice of any unregistered interest to the Monitoring Officer within 28 days of the meeting

(c) If you are the Leader or a Cabinet Portfolio Holder you may not exercise any of your delegated powers as a single member in relation to a matter in which you have a disclosable pecuniary interest or take any other step except to give written notice of any unregistered interest to the Monitoring Officer within 28 days of your becoming aware of the interest, or arrange for another person or body to deal with the matter.

Disclosable Interest	Description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within 12 months of your declaration of interests in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses.
Contracts	Any contract between you or your partner (or a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.
Land	Any beneficial interest in land which is within the area of the Council and which gives you or your partner a right to occupy the land or receive income.
Licences	Any licence held by you or your partner (alone or jointly with others) to occupy land in the area of the Council for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge)— (a) the landlord is the Council; and (b) the tenant is a body in which you or your partner has a beneficial interest i.e. a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest.
Securities	Any beneficial interest held by you or your partner in securities of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council; and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class. “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

1. Purpose of Report

To provide the Cabinet Members with an update on the Birmingham 2022 Commonwealth Games and the proposed legacy objectives for Solihull.

2. Decision(s) recommended

- 2.1 The Cabinet Member to receive a presentation about the council's preparation for the Birmingham 2022 Commonwealth Games
- 2.2 Review and comment on the legacy objectives for Solihull.

3. Matters for Consideration

The Birmingham 2022 Commonwealth Games are due to take place in July 2022. Solihull as a Host Authority is currently involved in the development of the games programme. We will also have the opportunity to align to the 6 months culture and arts festival that is planned to run from March to September 2022. In addition to the delivery of the games, the games are an opportunity to deliver a long term legacy.

- 3.1 The presentation will update Cabinet Member on the Councils progress on its

planning and delivery of the events that will take place at the NEC. As a host authority we work closely with the Organising Committee (OC) across a number of areas:

- Transport and Traffic Management;
- Highways and Infrastructure;
- Regulation and Enforcement;
- Resilience;
- Communications, Engagement, Volunteers and Promotion;
- Street Scene – cleansing and parks management;
- City Dressing and Wayfinding;
- Live sites, Queen Baton Relay and City activations.

3.2 In addition to the delivery of the games we received on the 9 July 2020, a briefing on the facility needs for pre-Games training camps. Officers are reviewing these requirements and will provide an update as appropriate.

3.3 A formal Project Board has been established led by the Assistant Director Communities and Partnerships to oversee all of the workstreams linked to the areas listed at 3.1 in this report.

3.4 As a result of Solihull's involvement in the Birmingham 2022 Commonwealth Games there will be a long lasting and sustainable positive benefit for Solihull citizens and our communities:

- The Games presents an opportunity to position Solihull as a visitor destination, as well as a key inward investment location, showcasing the strengths of the area and its facilities and developing cohesive marketing campaigns that raise the profile locally, regionally and internationally.
- COVID 19 has had a significant impact on the tourism, retail and hospitality sectors of Solihull, for which the Commonwealth Games presents the opportunity to aid recovery and capitalise on economic impacts for our local towns and centres
- The Games presents an opportunity to enhance joint working between our local businesses, developing 'packages' of bookable products and itineraries for visitors that will then have a lasting legacy for the tourism and visitor economy sector
- The Games presents an opportunity to develop the skills and capacity of the visitor economy and retail sectors, giving them the skills and training to support visitor 'welcome' as well as practical support to promote and run their business
- The CWG will need approx. 43,000 Games time roles including a trained workforce of at least 12,000 volunteers and we need to ensure Solihull residents benefit from these opportunities. Such as young people, those from under representative communities and the unemployed

- The Games are working with the West Midlands Combined Authority and partners, and have launched a new Commonwealth Jobs and Skills Academy to accelerate and amplify plans to improve regional skills and employment opportunities through the Games. There will be a focus on supporting young people and unemployed adults.
- Ensuring Communities involvement in events, festivals and sporting activity to support them to thrive.

3.5 We want to align Solihull’s approach to legacy with those of the Organising Committees which are:

- Ensure games for everyone - Opportunity for mass participation with low/no barriers to engagement.
- Targeted interventions - Ensuring specific audiences benefit from the opportunities
- Social action - Widen programmes and encourage participation in active citizenship lasting beyond the event
- Grow and succeed - Skills development, training and employment opportunities
- Sustainable success - How economic, social and environmental benefits of the Games can be taken forward

3.23 Our proposed overarching legacy objectives are detailed in the table below, we are currently working up some deliverable outcomes and will discuss some draft proposals in the presentation.
