## Disclosing Pecuniary Interests - What Must You Do?

(a) You must complete a declaration of your disclosable pecuniary interests, including those of your spouse/civil partner (or someone with whom you are living as such) and send it to the Monitoring Officer within 28 days of your election or appointment to the Council.

(b) When you attend a meeting of the Council, Cabinet, Scrutiny Board, Committee, Sub-Committee or Joint Committee etc, and a matter arises in which you have a disclosable pecuniary interest, unless you have been granted a dispensation, **you must:**

- Declare the interest if you have not already registered it
- Not participate in any discussion or vote
- Leave the meeting room until the matter has been dealt with
- Give written notice of any unregistered interest to the Monitoring Officer within 28 days of the meeting

(c) If you are the Leader or a Cabinet Portfolio Holder you may not exercise any of your delegated powers as a single member in relation to a matter in which you have a disclosable pecuniary interest or take any other step except to give written notice of any unregistered interest to the Monitoring Officer within 28 days of your becoming aware of the interest, or arrange for another person or body to deal with the matter.

Disclosable Interest	Description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within 12 months of your declaration of interests in respect of any expenses incurred by you in carrying out duties as a member, or towards your election expenses.
Contracts	Any contract between you or your partner (or a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest) <b>and</b> the Council (a) under which goods or services are to be provided or works are to be executed; <b>and</b> (b) which has not been fully discharged.
Land	Any beneficial interest in land which is within the area of the Council and which gives you or your partner a right to occupy the land or receive income.
Licences	Any licence held by you or your partner (alone or jointly with others) to occupy land in the area of the Council for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge)— (a) the landlord is the Council; <b>and</b> (b) the tenant is a body in which you or your partner has a beneficial interest i.e. a firm or body corporate in which you or your partner is a partner or a director, or in the securities of which you or your partner has a beneficial interest.
Securities	Any beneficial interest held by you or your partner in securities of a body where—  (a) that body (to your knowledge) has a place of business or land in the area of the Council; <b>and</b> (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; <b>or</b>  (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.  “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

**1. Executive Summary**

- 1.1 This report provides a mid-year update on the Children's Services Capital Programme for 2022/25

**2. Decision(s) Recommended**

- 2.1 The Cabinet Member for Children and Education is asked to approve:
- 2.2 a) The update to the Children Services Capital Programme for 2022/23 together with the outline programme for 2023/24 and 2024/25 (Appendix A) and;
- 2.3 b) The draft School Maintenance Programme for 2023/24 (Appendix B).

**Report Title:** Children's Services Capital Programme 2022/25 Update

**1. Matters for Consideration**

- 1.1 On 27<sup>th</sup> June 2022 the Cabinet Member approved the Children's Services Capital Programme for 2022/23 and the indicative programme for the following years 2023/24 and 2024/25.
- 1.2 This report seeks to update the programme to reflect the mid-year position for 2022/23, which is attached as **Appendix A**. Presently the update, which remains fully funded as illustrated through the funding streams within Appendix A, represents a revised total investment of £25.352m in the schools' estate for the 3 year period.
- 1.3 Additionally, a draft of the Schools Maintenance Programme for 2023/24 is attached as **Appendix B**. This highlights the schools that have been prioritised for essential maintenance works during next year and is also highlighted for the Cabinet Member's approval. This programme is subject to detailed design and costing.

**2. What options have been considered and what is the evidence telling us about them?**

- 2.1 The Children's Services Capital Programme includes projects which address the sufficiency, suitability and condition of the schools' estate.
- 2.2 The sufficiency of school places across the borough is evidenced within the School Organisation Plan, which was last approved by the Cabinet Member in September 2020.
- 2.3 Appraising the suitability of the school estate continues to be about ensuring our school premises are fit for purpose to support the effective delivery of teaching and learning and the drive to raise education standards. Asset management planning with individual schools continues to enable suitability issues to be identified and where possible addressed, often in works that are complementary to other projects focused upon places and condition. This can also be through the Landlord Approval process where schools have proposed using their own funding, given the priority they attach to such schemes.
- 2.4 In improving the condition of the school estate through planned maintenance, long term improvement or new build schemes, we are fundamentally addressing priorities, including backlog items, determined from our rolling programme of local stock condition surveys.
- 2.5 The SEND School Place Commissioning Strategy 2021-24, approved by Cabinet Member in September 2021, has identified a number of key priority areas for development of additional special places including expansion of existing schools to meet the short to medium term need, and through the delivery of a new special school to meet ongoing demand over the longer term.
- 2.6 This is also evidenced by the Government's Delivering Best Value programme suggesting the need for development of sufficient new specialist provision within borough.

### **3. Reasons for recommending preferred option**

- 3.1 The delivery of the Children's Services Capital Programme is structured through its subordinate programmes.

#### The North Solihull Primary Programme

This programme is now complete, and a minor contingency remains.

#### The School Improvement Programme

- 3.2 The expansion scheme at Alderbrook Academy is on programme to deliver the required additional 150 secondary pupil places by September 2023.
- 3.3 Following unforeseen delays during the initial stage of the expansion works at Cheswick Green Primary School, phasing has been adjusted for this project to reflect the current progress on site, with a planned greater proportion of the works to take place within the 2023/24 financial year. However, the scheme is still on programme to provide the additional 210 school places for September 2023 with remaining phases to be completed by the end of the calendar year.
- 3.4 A further longstanding proposal in this section of the programme is for the split site Valley Primary School to merge onto its junior campus. This received in principle approval from Cabinet on the 6 January 2020 enabling the project to progress to a broader development stage. Significant constraints have arisen owing to the requirements of Sports England to maintain the extent of playing field provision and the impact of inflation on the wider Capital Programme. Options are therefore being reconsidered, to include the future use of the vacant infant site, and further discussions will take place with the school. In the short to medium term there is a need to address some condition items.
- 3.5 Recent migration into the borough has seen a significant increase in demand for school places. Planning work is in progress to install additional modular accommodation at Widney Junior School to alleviate pressure on places in this area. This is to be part funded by the school and also by an additional 2022/23 Dedicated School's Grant (DSG) allocation to support pupil growth. Feasibility works are also underway with secondary schools in targeted areas to provide additional places.

#### The School Improvement Programme (High Needs Block)

- 3.6 A key investment is the conversion of the former Daylesford Infant School site creating a new space for Summerfield Education Centre. Work is progressing to programme and it is intended the new provision, under the Solihull Academy MAT will take occupancy early in 2023, vacating their current site at Auckland House. Work will then begin to demolish Auckland House as referenced in a report to Cabinet Portfolio Holder Children and Education on 27<sup>th</sup> June 2022 for and a provisional allocation has been made within appendix A to facilitate this. Discussions for the vacant Auckland House site and its future use are ongoing.
- 3.7 Works are complete for the Primary ARP North with both KS1 and KS2 pupils now in

occupation.

- 3.8 We have now prepared and handed over the site on Bosworth Drive to the DfE for the creation of the new Free School (The Heights). A bid for a second free school has also been submitted for 150 pupils. Should this bid prove successful an allocation will be made available from contingency to facilitate site preparation here.
- 3.9 Feasibility work on the expansion of SEMH primary provision south, at Tudor Grange Primary Academy- Yew Tree to include KS1 pupils is ongoing to deliver a new and expanded provision, an increased allocation has been included in the capital programme for this.

#### The School Maintenance Programme

- 3.10 The programme this year has delivered a roof replacement at Reynolds Cross Special School, and heat pump replacement schemes at Kingshurst Primary School and Forest Oak and Merstone Special Schools are underway.
- 3.11 The draft programme for next year, 2023/24 is highlighted in Appendix B and addresses priority maintenance items in the Council's schools. A core budget has been made available for this programme, as indicated within Appendix A. Additional funding from the Devolved Formula Capital Grant will be allocated when announced by the DfE.

#### General and School Programme

- 3.12 Three NHS properties were transferred to SMBC in October 2022 to enable the creation of Children's Homes. Works are anticipated to commence imminently with an estimated completion of Spring 2023.
- 3.13 This element of the capital programme, focused on school premises, relates to contingencies held for specialist access works for individual vulnerable pupils, works to sites and payments for temporary classrooms.
- 3.14 In the report to the Cabinet Member for Resources on 4<sup>th</sup> July 2022, regarding the reprovision of accommodation for youth facilities at Brackleys Way, it was approved that officers would be progressing designs for a new build solution. This design work is ongoing and an allocation, using the capital receipt resulting from the sale of Youth Workshops, has been made within the Appendix A to facilitate works here with a view to completing 2023/24. This amount will be supplemented by additional funding streams outside of this programme and will be subject to a separate report.

#### School Managed Projects

- 3.15 This section of the programme reflects schemes of work undertaken directly by our schools and depending on their value, individual projects are highlighted. In this instance, Fordbridge Community Primary School are no longer proceeding with their procurement of the modular classroom. Appendix A has been updated to reflect this.

4.2 Consultation and Scrutiny:

4.2.1 This programme reflects corporate, collaborative and school priorities in consultation with the various stakeholders and is also subject to the bi annual approvals by the Cabinet Member.

4.2.2 Individual proposals are further refined through public consultation with school stakeholders and their local communities at key stages of the development process.

#### 4.3 Financial implications:

4.3.1 Appendix A highlights the revised budget for 2022/23 of £10.960m and the proposed 3 year programme for 2022/25 total of £25.352m

4.3.2 In particular, Section 106 contributions from local developments have been allocated to maximise the most appropriate use of funding for certain key capital projects. Specifically as all education contributions relating to the Blythe Valley development have now been received, £0.817m this sum has now been applied to the secondary expansion previously undertaken at Tudor Grange Academy.

#### 4.4 Legal implications:

4.4.1 The Local Authority has a legal duty to secure sufficient childcare places in its area in line with its published sufficiency plan.

#### 4.5 Risk implications, including Risk Appetite:

4.5.1 Corporate Risk Registers are maintained for various elements of the Service Asset Management Plan and Children's Services Capital Programme and, essentially, it remains the case that across this relatively straightforward programme of works there are no red risks to report.

4.5.2 However, as with all areas of the Council's activities the effects of the pandemic and wider market conditions have generated uncertainty. With reference to projects within the programme it is the position that the feasibility work that underpins the early stages of our pre planning schemes will have been prolonged, consultation processes will have been delayed in line with corporate guidance and tenders and costs will have been reviewed.

4.5.3 Generally, that position, being dynamic and susceptible to rapid change, is currently improving but any specific concerns members have can be elaborated upon against individual project lines.

#### 4.6 Equality implications:

4.6.1 All existing and future schools building provision will take full account of the Public Sector Equalities Duty and access needs for staff, children and visitors with disabilities.
