

Solihull Together Progress Report

Health and Well Being Board, 8 November 2022

This report provides an update on the Outcomes Framework, the Mental Health Delivery Plan and the priority programmes of work.

Outcomes Framework

Further work with 'subject specialists' has enabled us to further refine the metrics for our Outcomes Framework. A number of changes have been made including:

- Outcome 8 People with additional needs experience care and support that helps them recover and maximise their independence (changed from People have access to the right care and support when and where they need it)
- Outcome 9 Our health and care services deliver good quality care and support to the population (changed from People working in our health and care services deliver good quality care and support to the population)
- Outcome 10 Our services work together to have a positive impact on outcomes and reduce health inequalities (changed from As anchor institutions, we work together to have a positive social, economic and environmental impact

The framework also now references to the ICS Inception Framework and the focus on health inequalities have been strengthened.

There are discussions taking place at ICS level about the development of the ICS outcomes framework, which is due at the end of November 2022.

Mental Health Delivery Plan

Our Solihull Mental Health Delivery Plan is nearing completion following considerable work with our six priority leads. We have also developed a summary of the plan. Both documents are attached to this report.

Consultation

This plan has been developed from existing strategies which are evidence based and have had extensive involvement of service users in development. People with lived experience are members of both delivery groups (CYP and Adults) both of which have overseen the development of the plan. In addition, we are currently liaising with service users on the plan working with;

- Solihull Parent and Carers Voice
- Urban Heard (vouth engagement)
- Local headteachers
- Commissioned providers to engage with Experts by Experience and service user groups



Longer term, there is agreement that we need to build an infrastructure for continuous co-production and involvement in the delivery and monitoring of the plan, which the Mental Health Provider Collaborative will develop.

Provider collaborative

To enable people's care to be more joined up we need to develop and create the conditions for decisions to be made collectively and co-operatively between citizens and professionals and between different organisations and agencies. The creation of a Mental Health Provider Collaborative will be an important part of this work. Subject to a robust assurance process, Birmingham and Solihull Mental Health Foundation Trust will take the role of 'lead provider' and be responsible for the commissioning and planning of NHS funded mental health provision and integrating services by working collaborative with SMBC and with other NHS and third sector organisations.

The collaborative will take responsibility for the following;

- **Delivery** implementation of the plan;
- Population Health Management utilising shared data from partners to
 understand the needs of people in Solihull, responding to this by improving
 plans to develop services that meet need, and for those most in need of
 support, and developing a needs profile so that we have the data we require
 to provide the right services and continually evaluate them.
- Engagement and ongoing involvement of people living and working in Solihull – working with the VCSE sector to capture and utilise their knowledge of what communities want, and value the things that support good mental health; utilising existing and creating new opportunities to engage and involve parents, carers, and people who use services or have lived experience, including young people in the ongoing monitoring of this plan; and working with Healthwatch to capture feedback from service users and non-users to understand needs
- Digital ensuring services are available digitally where appropriate to improve access and clarifying digital good practice and requirements to ensure all MH services are operating in line with the ICS Digital Strategy.
- **Communication and information –** ensuring joined up information is available to the public about our mental health offer and the services available

Oversight and Governance

Two delivery groups (one for adults and one for children and young people) will oversee delivery of the plan and monitor progress and impact. Both groups are multiagency and include health, local authority, service user and voluntary and community sector representatives. These will further develop as the provider collaborative becomes established. Progress will be reported regularly to ST, the new Place Committee and the Health and Wellbeing Board.

The plan will be discussed at Health and Adult Social Care and Children's Services, Education and Skills Scrutiny Boards on the 9 November 2022.

Update on Priority Programmes

The following provides and update on progress for each of Solihull Together's priority programmes

Ageing Well

Carers - The Carers Strategy 2022-2027 has been approved by Solihull's Cabinet and is awaiting approval by the ICB. The interim delivery plan is progressing in the project team and the detailed year 1 plan will be finalised.

Dementia – The Dementia Strategy entering final stages of design, for final governance review from Nov 2022

End of Life - Urgent & Emergency Care Workshop held 6th Sept 2022 with Marie Curie National and KPMG. Identified the following priorities for the system:

- o Communication of EoL Pathways and Services to the system
- Rapid review of urgent and emergency care pathways, identification of points of challenge and mitigation options.

Falls - Postural Stability Instruction has been extended to reach as many people as soon as possible. Higher levels of demand has meant that capacity has been reached, with 80 fallers on a waiting list. UCR pathways to be promoted with care homes and primary care.

Neighbourhood Integration - work is continuing in the form of preventative projects for example, delivery of lifestyle and NHS checks and work with schools to enable wider support from services. Proactive and anticipatory care is developing through a new small team that is being developed to work with GPS healthcare.

Home First - Negotiation regarding the Home First Tender and options for delivery. Agreement of the Home First Dashboard to inform flow and capacity

Exploitation Reduction

Health and Wellbeing Board receives separate stakeholder briefings on the progress and plans for Exploitation Reduction work.



Health Inequalities

The Health Inequalities Board is refining the action plan and has identified leads for each priority and enabler. There is also work being undertaken to ensure that the action plan is aligned to the BSOL Health Inequalities Strategy which is out for consultation.
