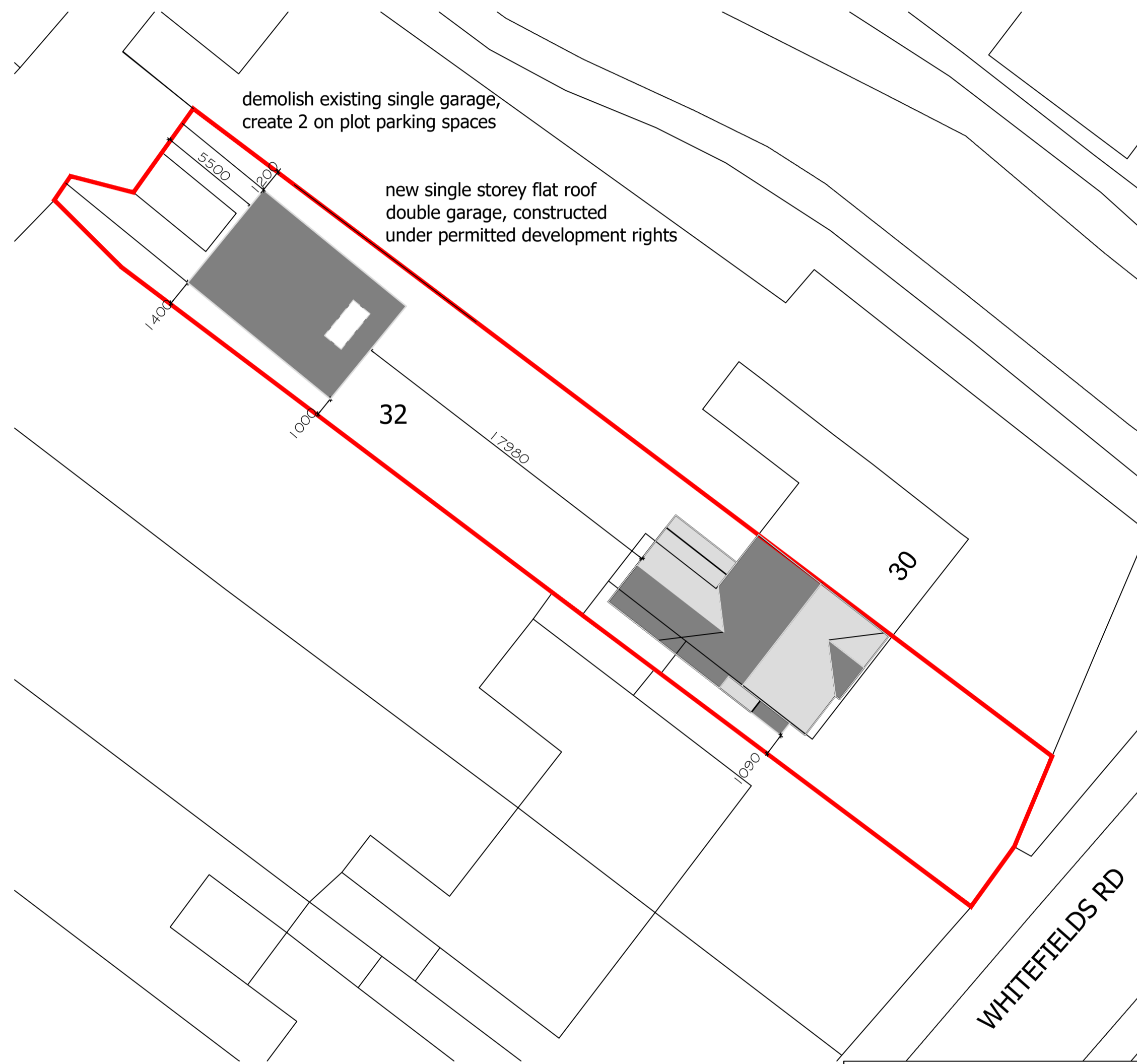
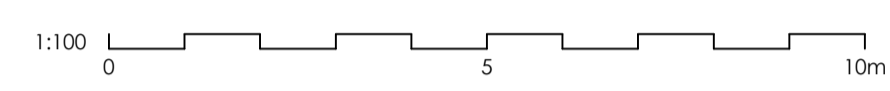


EXISTING FRONT ELEVATION

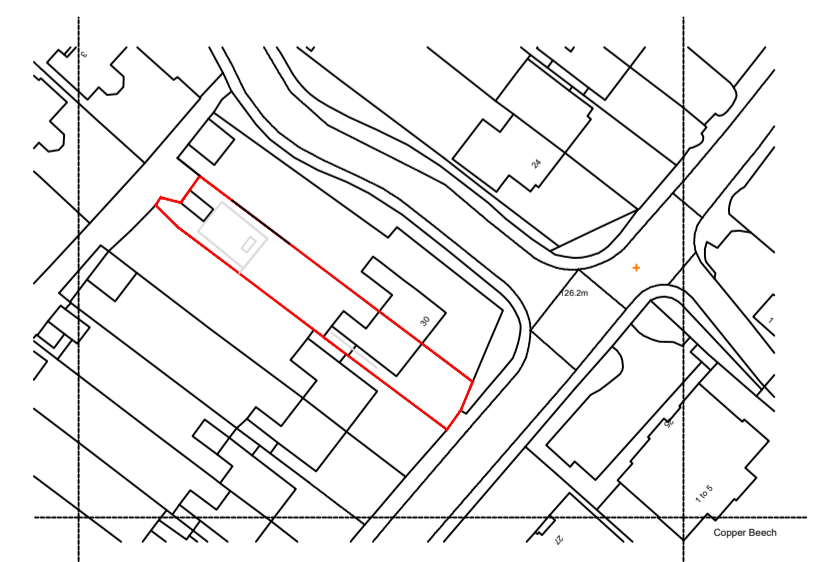
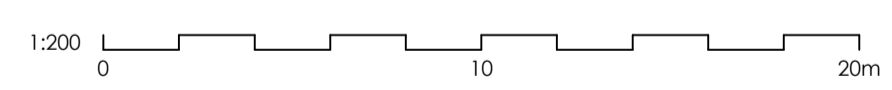
EXISTING SIDE ELEVATION

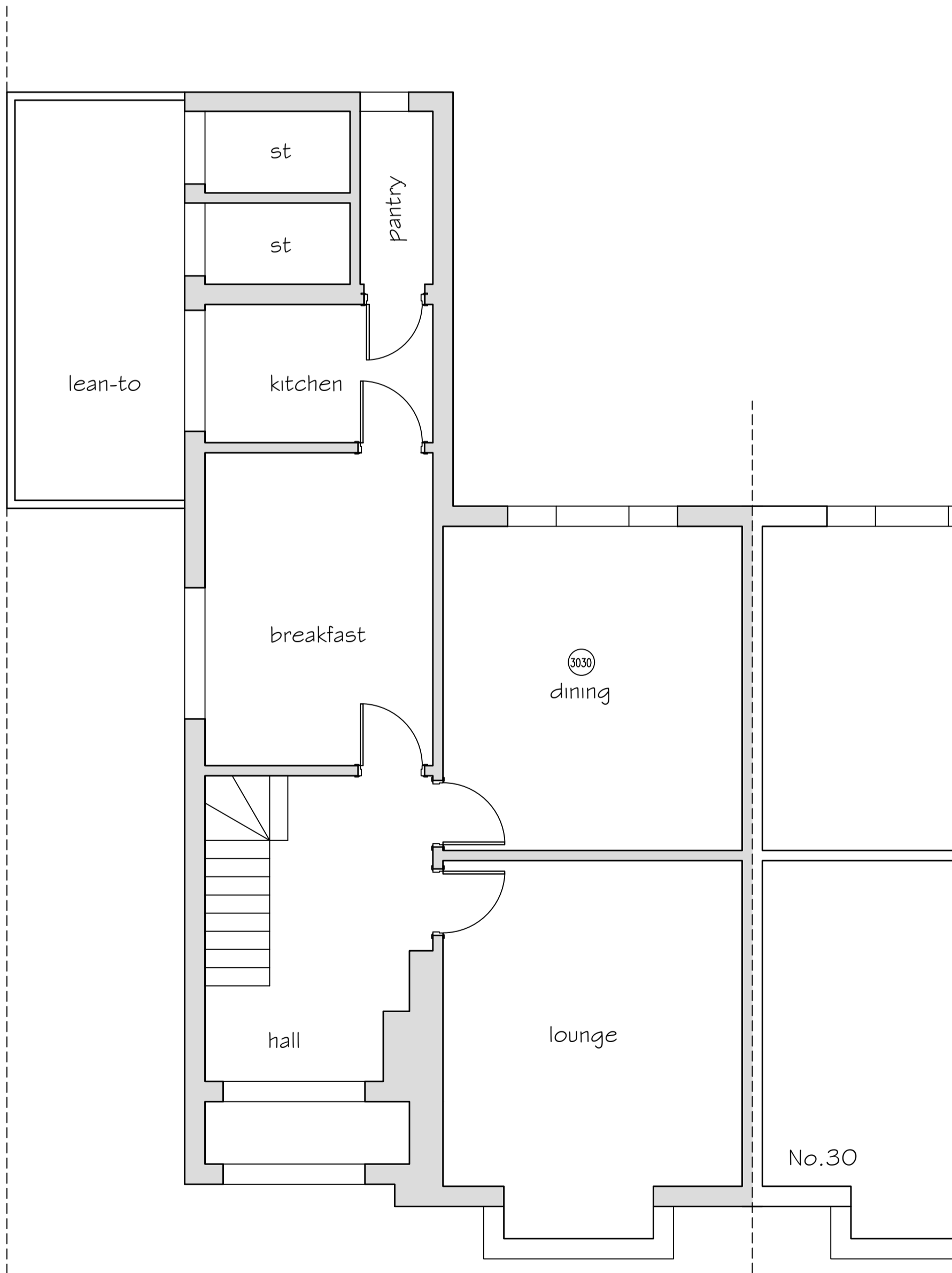
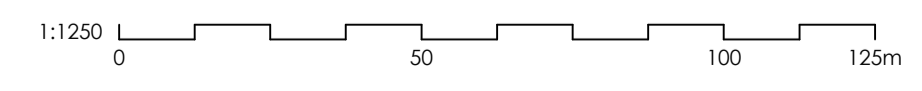

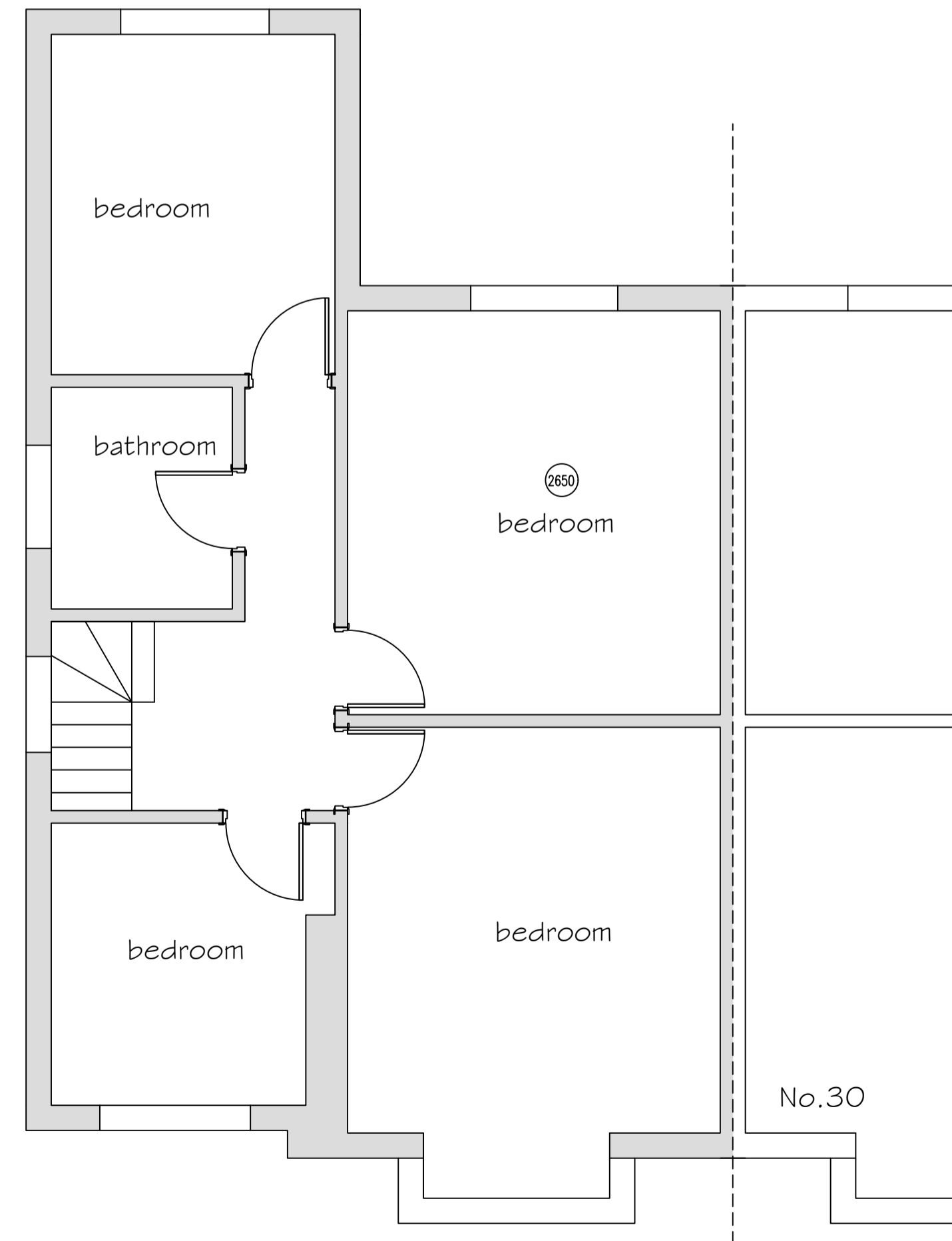
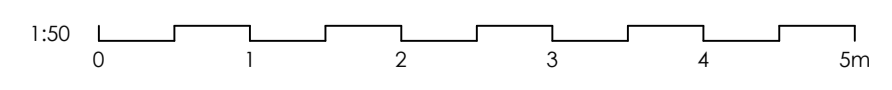
PROPOSED SITE PLAN

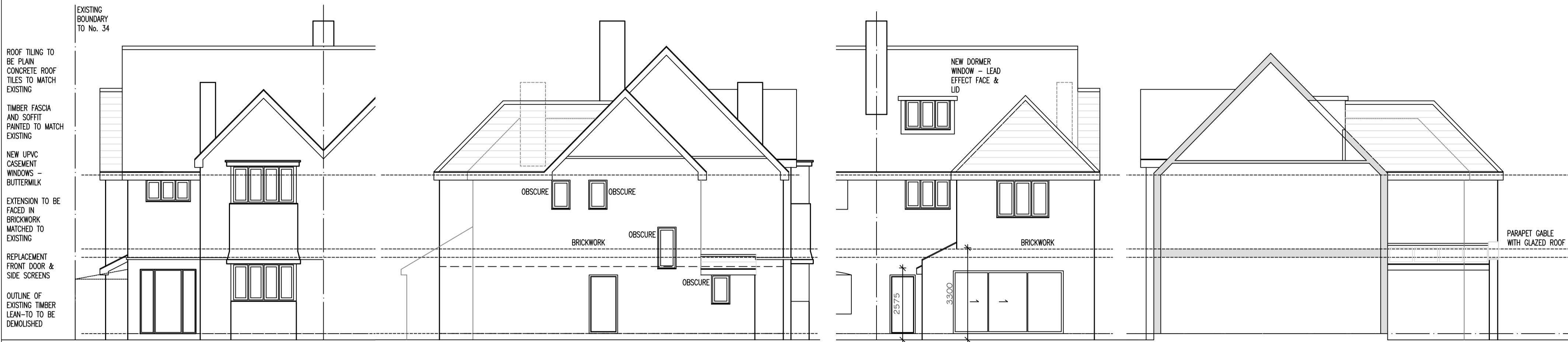

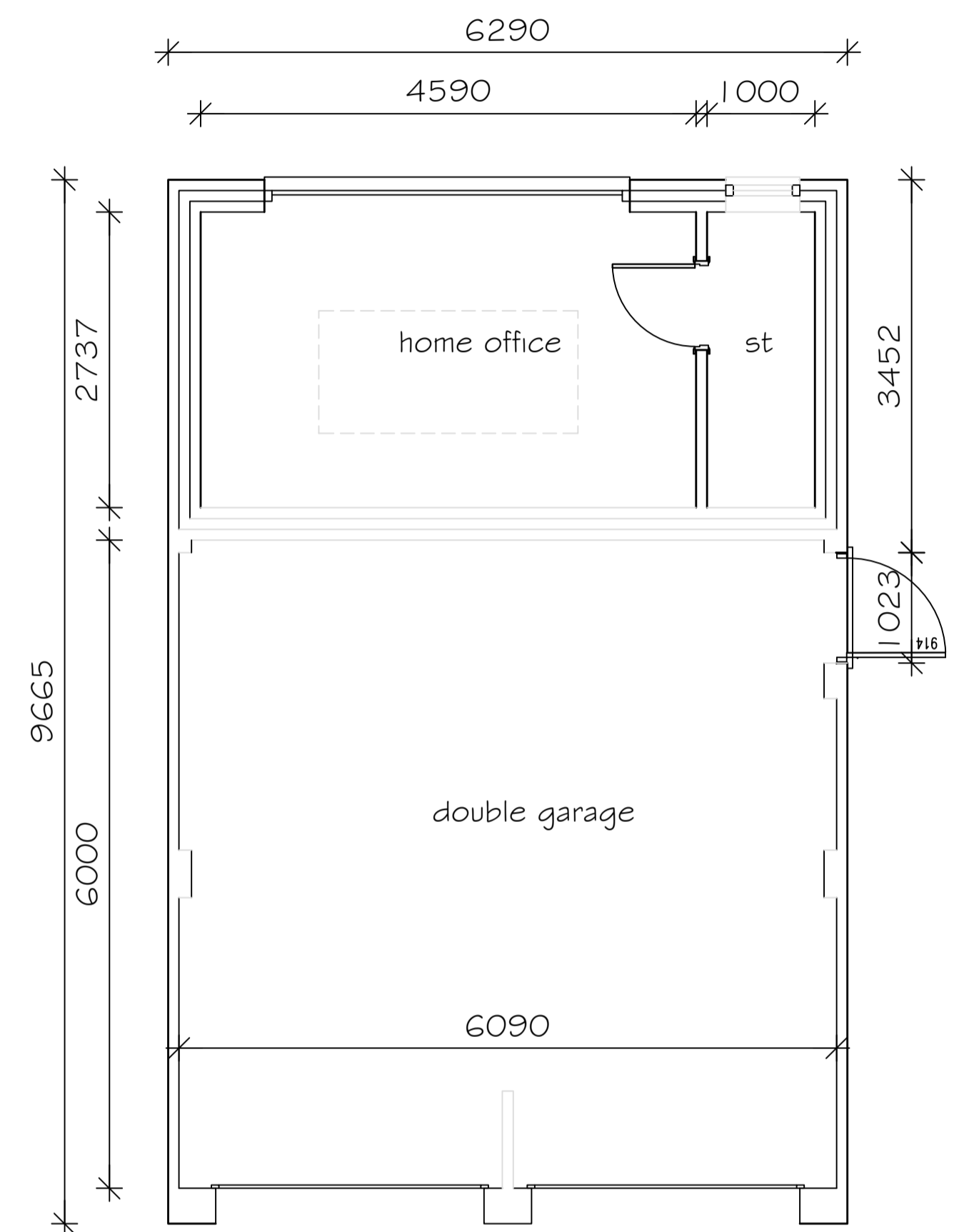
PROPOSED FRONT ELEVATION

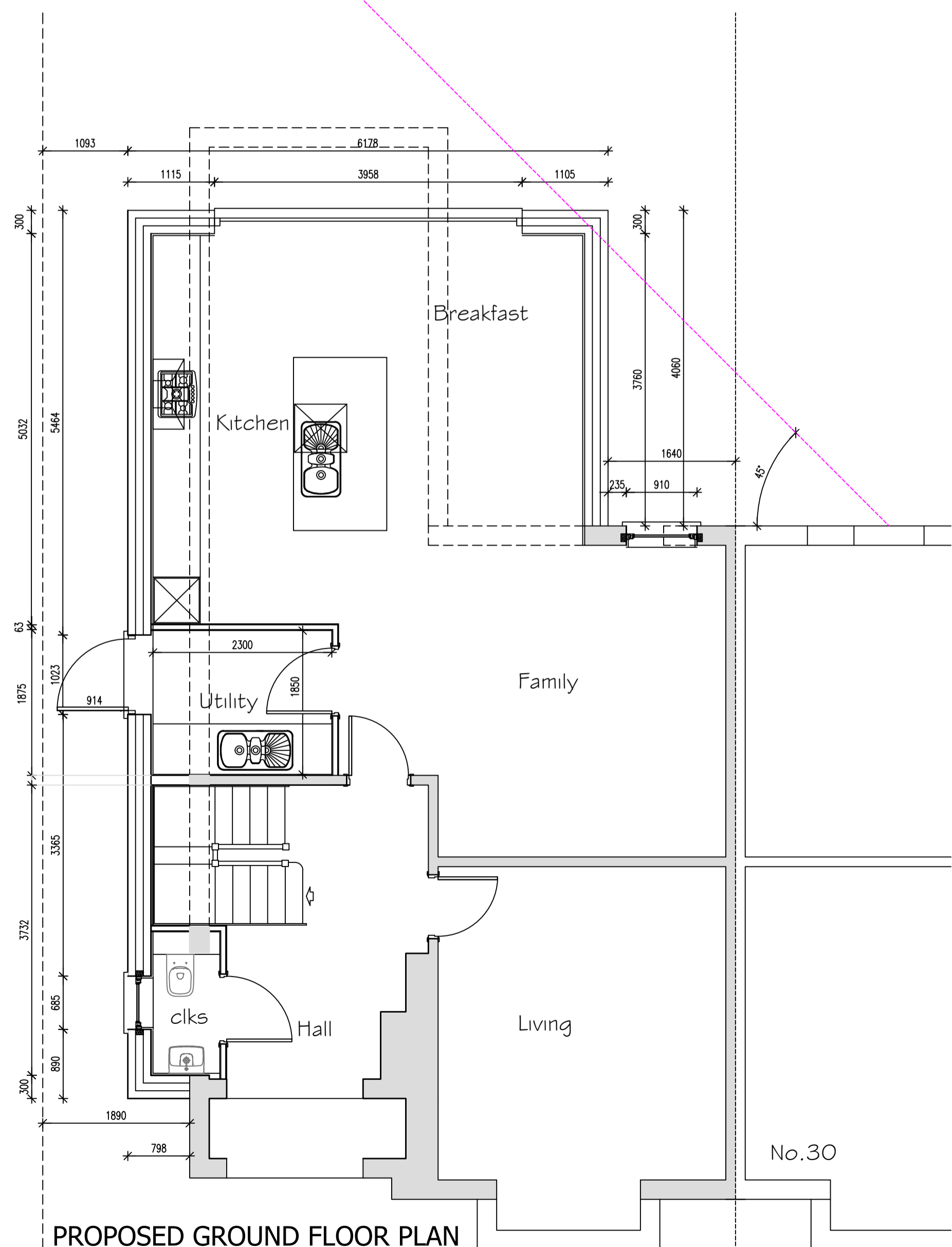

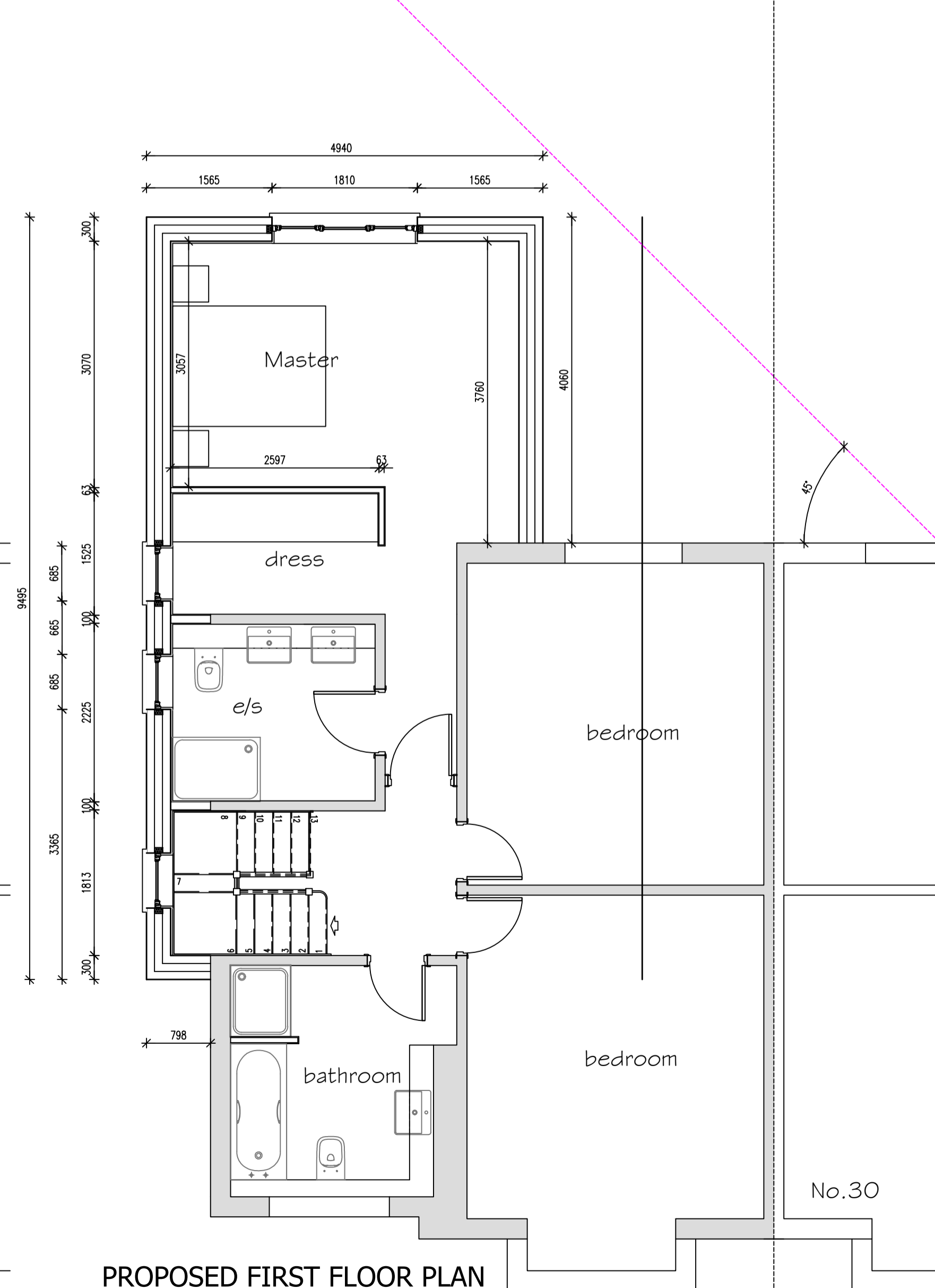
PROPOSED DETACHED GARAGE ELEVATIONS 1:100 SCALE



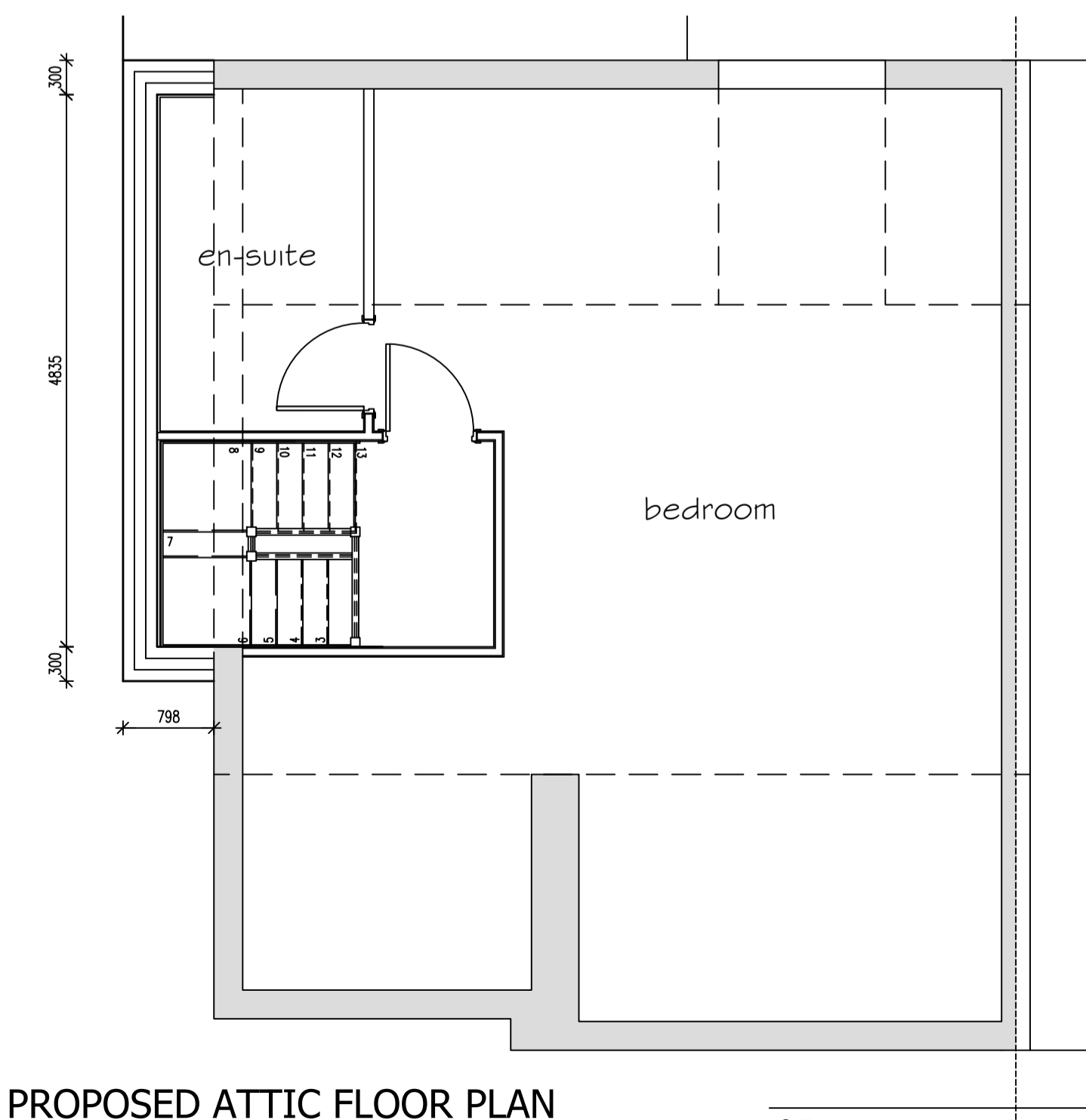
