1. Executive Summary

- 1.1 This report sets out details of the Government's current consultation on planning reforms and seeks approval for the Council's intended response to the consultation.
- 1.2 The Government is currently consulting on reforms to the planning system covering a range of issues covering both plan making and future approaches to determining planning applications. Alongside the consultation is a draft version of intended changes to the National Planning Policy Framework (NPPF).
- 1.3 It is the Government's intention that some policy changes will be in place by spring 2023 via the publication of a revised NPPF, whilst other changes will follow when the Levelling-up and Regeneration Bill receives Royal Assent.
- 1.4 This report outlines the nature of the reforms and sets out the Council's intended response to the consultation questions.

2. Decision(s) Recommended

- 2.1 That Cabinet Member notes the Government's consultation on reforms to the planning system.
- 2.2 That authority to respond to the consultation be delegated to the Assistant Director for

Growth and Development, in consultation with the Cabinet Member for Climate Change, Planning & Housing. Such response shall be based upon the draft set out in appendix D, as may be amended in light of the comments made during the Cabinet Decision Session.

Report Title: Consultation on Planning Reforms

3. Matters for Consideration

- 3.1 On 22nd December 2022 the Government published a consultation "Levelling-up and Regeneration Bill: Reforms to National Planning Policy¹" alongside which was a document² setting out intended changes to the NPPF. The consultation runs until 2nd March 2023 and views on the reforms are invited.
- 3.2 It is the Government's intention that some policy changes that are being consulted upon will be in place by spring 2023. Other reforms, including those that will need legislative changes being pursued through the Levelling-up and Regeneration Bill³. will follow in due course after a fuller review of the NPPF. These wider ranging changes are expected to "go live" in late 2024.
- 3.3 The intended reforms cover the following areas:
 - Providing certainty through local and neighbourhood plans
 - Planning for housing
 - A planning system for communities
 - Asking for beauty
 - Protecting the environment and tackling climate change
 - Onshore wind and energy efficiency
 - Preparing for the new system of plan making
 - National development management policies
 - Enabling levelling up
 - Wider changes to national planning policy in the future
 - Practical changes and next steps
- 3.4 A summary of the reforms is provided in appendix C. This takes the form of an article from the technical press⁴ that reviewed the main components of the reforms.
- 3.5 The consultation sets out 58 questions set out to capture views on the changes. These are set out in appendix D together with draft responses that are intended to form the basis of the Council's response to the consultation.
